Former adviser Azizul Haque passes away

Former adviser to the interim government of 2007 and former Inspector General of Police (IGP) M Azizul Haque died of a massive heart attack at his Uttara residence in the city on Wednesday, reports BSS. He was 84. He left behind his wife, three sons and a host of relatives, well-wishers and admirers to mourn his death.

The nama-j-e-Janaza of Azizul was held at the St Shru Mia auditorium at Rajshahi Police Lines after John prayers where senior police officers, retired police officers and his relatives and well-wishers joined. He was buried at a graveyard in the city's Uttara area after Asr prayers.

Azizul Haque, hailed from a respectable Muslim family of Jhilly village under Faridpur Sadar, joined the then Pakistan police service as an assistant superintendent of police in 1965.

Haque was promoted as the IGP on April 22 in 1996 and performed his duties till



managing director of the showroom, took four cars from the saleroom in between November 26 and December 4, under Delivery Chalan, with the promise to sell those cars.

However, Md Inadul Haque Khan alias Nawshad, an automobile trader who owns the showroom, learnt that Jarak and Jamir removed those cars with an intention to steal them.

On January 5, Nawshad filed a case with the police station.
